Prioritization of VTrans Capital Program Projects

- 13 D. Currier next presented to the TAC the list of Capital Program Projects for ranking. In order
- 14 for VTrans to spend funds on a project it must be listed in the Transportation Capital Program.
- 15 VTrans submits a Capital Program to the legislature each year and the legislature must approve
- 16 the list in order for projects to advance. The Capital Program categorizes projects according to
- 17 the following status:
- 18 **Candidate** A project gets on the Candidate list after it has completed the planning process
- and has been accepted by CVRPC and passed onto VTrans.
- 20 **Development & Evaluation (D&E)** A project moves from the Candidate list to the
- 21 Development & Evaluation list if preliminary plans are expected within 12 to 24 months.
- 22 Front-of-the-Book (FOB) Front-of-the-Book projects are part of VTrans four-year program. A
- 23 project moves from the Development & Evaluation list to Front-of-the-Book when it has
- 24 completed preliminary plan development.

- 26 The TAC Capital Program Project list included a total of 22 projects in the following program
- areas paving, roadway, bridge (State and Town) and safety/traffic projects. Each project was
- 28 presented and its ranking discussed. The TAC helped a consensus vote, which was unanimous,
