Re: CVRPC FFY 2019 TPI Budget Adjustment

ACTION REQUESTED: Approve the budget amendment and authorize the Executive Director to sign the agreement amendment.

CVRPC has an amendment to its FFY 19 Transportation Planning Initiative (TPI) agreement. The amendment proposes to adjust the budget to reflect adjustments among tasks and supplies. For this agreement, CVRPC must close the agreement having expended within 10% of each budgeted task. The adjustment shifts funding among tasks based on an analysis of use trends and anticipated work in September. Exhibits 2-3-4 reflect the adjusted budget.

Details on the budget adjustment are enclosed. Items in red text on Exhibit 4 show specific areas where staff hours or expenses have been adjusted.

Task 1 – Program Administration: Reduced \$3,335 based on use trends.

Task 2 – Public Participation and Coordination: Reduced by \$1,413 based on use trends.

Task 3 – Long Range Planning: Added \$1,156 based on use trends.

Task 4 – Short Range Planning: Reduced by \$192 based on use trends.

Task 5 – Project Development Planning: Added \$3,783 based on use trends.

Task 6A – Other Planning – VT Culverts: No change.

Task 6B – Other Planning – Watershed Planning: No change.
