#### 1. Introductions

## 2. New Planning Studies for the FY16 Work Program.

Staff explained that there may be only \$20,000 available for planning studies. Tom described the need to study the Main St./Barre St. Intersection, to address traffic operations and a better bicycle/pedestrian crossing of Main St. to connect the existing bike paths. Steve L. described the poor condition of the Stowe St. Bridge in Waterbury, and the need for an improved sidewalk. The Town of Barre didn't come. Staff explained the straightening of Reservoir Rd. in Orange, and the fact that the Town applied to the Class 2 TH Program. Greg would like to study an alternate alignment for the Cross Vt Trail from US 2 in Moretown, an assessment of the Lover's Lane Bridge, and conducting use counts on existing sections of the trail. Will explained that the need for CVRPC funding for the Mad River Recreation isn't there anymore, because they have other funding, and they would like to redirect the funds to study new trails on the Tenney property. The TAC discussed the transportation function of this trail, and suggested Will change his request.
