STATE UPDATES

Mask Mandate Effective August 1st

On Friday August 24, Governor Scott signed an [executive order](#) requiring masks to be worn indoors and outdoors where social distancing is not possible. This order applies to everyone over the age of two, except when eating, drinking, exercising or participating in strenuous activity. Additionally, those with medical reasons not to wear a mask will also be exempt; no written documentation will be required in order to preserve the medical privacy of individuals.

Businesses, nonprofits, and government entities are required to implement measures notifying customers or clients of the requirement to wear masks/facial coverings. This can include signage or denial of entry or service to customers/clients who decline to wear masks/facial coverings. State CARES Act

Funding Through Municipal Grants

The Vermont Legislature passed Act 137 of 2020 to distribute Coronavirus Relief Funds to various entities in Vermont. Sections 7 - 10 appropriate \$13 million to Vermont units of local government to reimburse eligible COVID-19 expenses, and \$2 million to assist municipalities in digitizing land records for online public access. The Agency of Administration, including the Vermont Department of Taxes, will be responsible for distributing the grant funds. The Dept. of Taxes will be contracting with Regional Planning Commissions to assist municipalities to document eligible expenses.

Expenses are only eligible for reimbursement to the extent that they are not covered by insurance or other federal funding sources, including funding provided by the Federal Emergency Management Agency (FEMA). Therefore, it is imperative that your unit of local government apply for FEMA funding for those expenses which are eligible through the FEMA Public Assistance program prior to submitting your application for the LGER Grant. For FEMA-eligible costs, LGER will cover the 25% non-FEMA match. For more information on how to apply for FEMA funding, go to <https://vem.vermont.gov/applicant>.

Two assistance programs are available.

Local Government Expense Reimbursement Grant (LGER) – Reimburses eligible COVID-19 expenses incurred on or before December 30, 2020, including hazard pay, supplies and equipment, sanitation, facility alterations, overtime compensation, redirection of staff for first-response needs, and any other eligible COVID-19 expenses not covered by other funding sources, including funding provided by the FEMA. As this is pass through CARES Act funding, federal guidelines and information is available through the Vermont Department of Finance and Management at <https://tax.vermont.gov/coronavirus/municipal-grants>

Digitization of Land Records Grant – Reimburses qualifying municipalities for certain costs associated with making digital copies of land records available online for public access through a secure portal. The grants are being issued to provide economic support to town offices which have been impacted by increased customer demand due to the COVID-19 public health emergency but are otherwise unable to successfully allow those customers to search land records. The funds can be used both to pay necessary expenditures that qualifying municipalities face and costs directly associated to digitizing land records. Vermont's information management standards apply and are available at <https://sos.vermont.gov/vsara/manage/information-governance/standards/>.
