The Town of Fayston, Vermont 2020 Town Plan is an update to the previous 2014 Fayston Town Municipal Plan. Much of the data has been updated to reflect current trends in the area, and new maps have been included.

Staff Review

CVRPC staff reviewed the Municipal Plan for following items:

a) confirmation of the planning process under 24 VSA §4350(a);

- ☒ is engaged in a continuing planning process that, within a reasonable time, will result in a plan which is consistent with the goals contained in section 4302 of this title; and

Staff findings and recommendations: Staff finds the Town of Fayston to be engaged in a continuing planning process and is maintaining its efforts to provided funds for planning purposes.

b) approval of the municipal plan per 24 V.S.A. § 4350(b);

☒ **consistency with the State goals established in section §4302**

Staff findings and recommendations: Staff finds the plan to be consistent with the State Goals, and provides the following recommendations for the next update:

- *State Goal 11: To ensure the availability of safe and affordable housing for all Vermonters.*
 - (C) *Sites for multi-family and manufactured housing should readily available in locations similar to those generally used for single-family conventional dwellings.*
 - Fayston's current zoning regulations permit multi-family housing through the Planned Residential Development (PRD) provision. It may interest the Town to consider the implications of revising the zoning bylaw in an attempt to allow for more types of housing across Town and reduce the review process for such housing developments.
- *State Goal 13: To ensure the availability of safe and affordable child care and to integrate child care issues into the planning process, including child care financing, infrastructure, business assistance for child care providers, and child care work force development.*
 - The most recent update to the Fayston Town Plan includes a satisfactory discussion on child care provision in Town and takes a stance on not preventing it from being built. However, the plan does not identify clear action items that the Town may implement to address the need that may be present. The Town may have an opportunity to utilize their location in proximity to Sugarush to explore childcare opportunities for seasonal workers.

Examples to address this need include: Maintaining a listing of providers in or near Fayston on the municipal website, encouraging local businesses to offer assistance to childcare businesses, and developing partnerships with large employers such as Sugarbush Resort to identify workforce childcare needs and

develop strategies to meet those needs. More information on meeting the State's Child Care goal may be found in [this document published by the Windham Regional Commission](#).

Staff findings: staff finds the plan to be compatible with the regional plan.

Staff findings and recommendation: staff finds the plan to contain all of the required elements and provides the following recommendations for the next update:

- (3) *A utility and facility plan, consisting of a map and statement of present and prospective community facilities and public utilities showing existing and proposed educational, recreational and other public sites, buildings and facilities, ...*
 - Staff have reviewed the Community Facilities chapter and the Road Network map and understands that it has satisfied the plan element required by Statute. Staff recommends in a future update that a separate map including town-owned utilities and facilities is included.

Staff would also note that as a member municipality of CVRPC, the Town is entitled to 12 hours of GIS mapping at no cost, and CVRPC staff would be happy to assist in developing this for future updates.

RESOLUTION

Whereas Title 24, VSA, Section §4350 requires that regional planning commissions, after public notice, shall review the planning process of member municipalities and shall so confirm when a municipality:

1. is engaged in a continuing planning process that, within a reasonable time, will result in a plan that is consistent with the goals contained in 24 V.S.A. § 4302;
2. is engaged in a process to implement its municipal plan, consistent with the program for implementation required under 24 V.S.A. § 4382; and
3. is maintaining its efforts to provide local funds for municipal and regional planning purposes;

Whereas as part of the consultation process, a regional planning commission shall consider whether a municipality has adopted a plan;

Whereas a regional planning commission shall review and approve plans of its member municipalities, when approval is requested and warranted, and a commission shall approve a plan if it finds that the plan:

1. is consistent with the goals established in 24 V.S.A. § 4302;
2. is compatible with its regional plan;
3. is compatible with approved plans of other municipalities in the region; and
4. contains all the elements included in 24 V.S.A. § 4382(a)(1)-(12);

Whereas the Town of Fayston prepared a municipal plan in accordance with 24 V.S.A Chapter 117;

Whereas the Central Vermont Regional Planning Commission concluded that the *Fayston, Vermont 2020 Town Plan* meets the requirements for approval; now, therefore, be it

Resolved, that the Central Vermont Regional Planning Commission:

1. approves the *Fayston, Vermont 2020 Town Plan*, adopted September 22, 2020; and
2. consulted with and confirms the planning process of the Town of Fayston.

Under 24 V.S.A. § 4350, when an adopted municipal plan expires, its approval and confirmation of the municipality's planning process also expire. Recommendations made by the Central Vermont Regional Planning Commission are attached and should be considered when developing the next municipal plan.

A municipality that has adopted a plan may define and regulate land development in any manner that the municipality establishes in its bylaws, provided those bylaws are in conformance with the plan and are adopted for the purposes set forth in 24 V.S.A. § 4302.

The *Northfield Town Plan 2020-2028* is a complete update and new revision to the previous 2014 *Northfield, Vermont Town Plan*. The plan has undergone a completely new format, with the inclusion of new maps, and a reformatting of the chapters. The plan has condensed in page-length, but has included new forest integrity and flood resilience elements, as well as an enhanced energy plan included in the place of the energy element.

Staff Review

CVRPC staff reviewed the Municipal Plan for following items:

a) confirmation of the planning process under 24 VSA §4350(a);

Staff findings and recommendations: Staff finds Northfield to be engaged in a continuing planning process and is maintaining its efforts to provided funds for planning purposes.

Staff findings and recommendations: Staff finds the plan to be consistent with the State Goals, and provides the following recommendations for the next update:

- *State Goal 3: To broaden access to educational and vocational training opportunities sufficient to ensure the full realization of the abilities of all Vermonters.*
 - The Education section of Northfield's plan adequately lists public educational opportunities and enrollment numbers for the educational institutions in Town.

Staff would like to see further consideration of future uses for educational facilities and other needs for the facilities themselves, as well as a regional

workforce development context outside of public K-12 and Norwich university. The inclusion of these opportunities could bolster the Town's economic development goals as they pertain to attracting and training a more skilled workforce.

- *State Goal 13: To ensure the availability of safe and affordable child care and to integrate child care issues into the planning process, including child care financing, infrastructure, business assistance for child care providers, and child care work force development.*
 - Northfield's plan is consistent with the above childcare goal and while not obligated to provide child care – the Town has a university and thriving village economy within their borders and may have an opportunity to act as a leader in planning for child care, especially considering the Town's recent work in hiring an Economic Development Specialist.

Examples to address this need include: Maintaining a listing of providers in or near Northfield on the municipal website, encouraging local businesses to offer assistance to childcare businesses, and developing partnerships with large employers to identify workforce childcare needs and develop strategies to meet those needs. Staff findings and recommendations: Staff finds that the *Northfield Town Plan 2020-2028* is consistent with the goals and policies in subdivision 4302(f)(1)(A) through (E) above.

Staff findings and recommendations: Staff finds that the *Northfield Town Plan 2020-2028* meets the standards for issuing a determination of energy compliance and offers the following suggestions in the next update:

- *Standard 9G: Does the plan demonstrate the municipality's leadership by example with respect to the deployment of renewable energy?*

Staff recognizes that commitment to using municipal funding for renewable energy generation requires significant community support. In future revisions, staff suggests that the Town of Northfield assess feasibility for municipal deployment of renewable energy in support of this standard beyond considering carbon footprint in municipal expenditures. Options may include municipal generation for an EV charging station, municipal generation at a park-and-ride, etc.

- *Standard 12: Does the plan identify potential areas for development and siting of renewable energy resources?*

Staff recognizes that the inclusion of CVRPC-provided data and maps by reference allows the Town to utilize the two included maps to satisfy this mapping requirement. For ease of reading in future updates, Staff recommends including a map of the known and possible constraints that are referenced in the mapping of solar and wind resources. This will better inform readers where the specific constraints are located within the Town in order to better plan for possible solar and wind generation facilities.

DETERMINATION OF ENERGY COMPLIANCE

Determination of Energy Planning Compliance Pursuant to 24 V.S.A. §4352

Northfield Town Plan 2020-2028, adopted August 11, 2020

I. Procedural History

1. On August 14, 2020, the Town of Northfield submitted the *Northfield Town Plan 2020-2028* to the Central Vermont Regional Planning Commission ("CVRPC") for a determination of compliance with the enhanced energy planning standards set forth in 24 V.S.A. §4352.
2. On September 4, 2020, notice of a public hearing scheduled for September 21, 2020 was posted on the website of the entity from which the determination is requested.
3. On September 5, 2020, notice of a public hearing scheduled for September 21, 2020 was published in the Barre-Montpelier Times Argus.
4. On September 4, 2020, notice of a public hearing scheduled for September 21, 2020 was emailed directly to the Town of Northfield and posted in 3 other locations within the region.
5. On September 21, 2020, CVRPC's Municipal Plan Review Committee convened a public hearing via GoToMeeting software with no physical location per the standards set forth in Act 92 during the Covid-19 Pandemic. The Municipal Plan Review Committee recommended that the *Northfield Town Plan 2020-2028* receive a determination of energy compliance with the enhanced energy planning standards set forth in 24 V.S.A. §4352.
6. On September 24, 2020, CVRPC's Board of Commissioners reviewed the recommendation of the Municipal Plan Review Committee and voted to approve the determination of energy compliance pursuant to 24 V.S.A. §4352 with _____ (Votes).

II. Public Comments

The Town of Northfield held four public hearings on the *Northfield Town Plan 2020-2028*, and received public comments that were ultimately incorporated into the plan. None of these comments pertained specifically to the enhanced energy planning criteria and focused on historic development, rural lot size minimums, and restrictions of rural housing

development. ____ members of the public were present at the September 21, 2020 Municipal Plan Review Committee meeting.

III. Conclusions

1. The *Northfield Town Plan 2020-2028* includes an energy element that has the same components as described in 24 V.S.A. §4348a(a)(3) for a regional plan and is confirmed under the requirements of 24 V.S.A. §4350.
2. The *Northfield Town Plan 2020-2028* is consistent with following State goals:
 - A. Vermont's greenhouse gas reduction goals under 10 V.S.A. § 578(a);
 - B. Vermont's 25 by 25 goal for renewable energy under 10 V.S.A. § 580;
 - C. Vermont's building efficiency goals under 10 V.S.A. § 581;
 - D. State energy policy under 30 V.S.A. § 202a and the recommendations for regional and municipal energy planning pertaining to the efficient use of energy and the siting and development of renewable energy resources contained in the State energy plans adopted pursuant to 30 V.S.A. §§ 202 and 202b (State energy plans); and
 - E. The distributed renewable generation and energy transformation categories of resources to meet the requirements of the Renewable Energy Standard under 30 V.S.A. §§ 8004 and 8005.
3. The *Northfield Town Plan 2020-2028* meets the standards for issuing a determination of energy compliance included in the State energy plans as developed by the Vermont Department of Public Service.
