Updating Your Town Plan for Forest Integrity (Act 171)

December 7, 2020 | 1:00pm-2:00pm

Since January 1st, 2018, towns and Regional Planning Commissions are required to identify forest blocks and habitat connectors, as well as plan for development in those places in ways that minimize forest fragmentation. This requirement asks towns to look at the larger patterns of forests and dive into the science of what is known about connectivity in their region at multiple scales. Some of the data involved is immediately actionable, but some of the models warrant caution and additional research. VTrans 2021 External Research Projects

Do you have an idea for a research project that the Vermont Agency of Transportation (VTrans) should consider? Every year, VTrans funds 2-4 external research projects and the submittal process is open to everyone. Project ideas must be submitted by December 18, 2020 for consideration in the 2021 program. To move forward, research ideas must be matched with a VTrans Technical Staff Champion who understands the value of the research and the benefit to the Agency. To submit your research idea, complete **this form** before December 18th.

VTrans is also developing a Qualified Researcher List. To generate this list VTrans will release a Request for Qualifications (RFQ), open to all interested entities, by early December 2020. Organizations on the Qualified Researcher List will receive Problem Statements in January 2021 generated by the VTrans Technical Staff Champions that are matched to the submitted research project ideas. Research teams interested in responding to a specific research project will submit two page Letters of Interest by the end of January.

New VT DEC Stormwater General Permit 3-9050 In Effect 12/1/2020

All applications for an operational stormwater permit for new development, redevelopment, permit renewal, or for "three-acre sites" received on or after 12/1/20 must be under General Permit 3-9050. DEC is in the process of updating their website and application forms. They hope to have the 3-9050 Notice of Intent forms available by 12/1/20 but expect there may be some glitches and delays as the new system is launched. Your patience is appreciated as they make this transition. Continuity of Operations Plans and Mutual Aid Agreements between Municipalities

To facilitate emergency planning in response to the COVID-19 pandemic as winter approaches, road and maintenance crews are encouraged to:

- Review and/or update mutual aid agreements and continuity of operations plans (COOP) as a way to share resources and or services with other municipality. VEM and VLCT have templates available at the links below (these are written to accommodate a wide range of situations, so please customize for your municipality).

 - Research and establish private contracts that can assist in road clearing, especially if crews may have to quarantine or are sick
 - Pre-identify and prioritize routes for emergency access that should be cleared first.

Department of Public Service: Arrearage Assistance to Municipal Water and Sewer/Wastewater Departments, Community Water Systems, Fire Districts

The VT COVID-19 Arrearage Assistance Program (VCAAP) is providing assistance with past-due bills from an expanded list of water and wastewater (sewer) utilities. In addition to helping out with past-due electric, landline telephone, private water company, and Vermont Gas bills, consumers can now also apply to VCAAP for assistance with their delinquent water and sewer/wastewater charges. The expanded list of utility bills that VCAAP can help with now includes municipal water and sewer/wastewater departments, community water systems, fire districts, and other systems that provide water and sewer/wastewater services to consumers.

As with other regulated utility charges, those eligible for funding under the VCAAP must be at least 60 days in arrears. Consumers will also need to attest to financial hardship due to COVID-related loss of income. Consumers will not need to upload a water and sewer/wastewater bill with the application.
