Reminder: Tier II Reports Are Due March 1st!

As established in the federal [Emergency Planning and Community Right-to-Know Act \(EPCRA\)](#), Tier II reports are submitted annually to the State, the Local Emergency Planning Committee (LEPC), and the local responding fire department to increase the public's knowledge of hazardous materials in their communities, and improve emergency planning.

RFP's, Grant Information, Applications & Deadlines

Farm to School Grants

COVID-19 delayed the Vermont Agency of Agriculture, Food and Markets farm to school grant programs last fall. Three grant programs are now available and will begin taking applications soon. The [Community Supported Agriculture \(CSA\) Grant](#) reimburses 80% of the cost of CSA shares. The [Farm to School Vision Grant](#) supports innovative ideas that address emergent issues within farm to school. The [Farm to School Child Nutrition Implementation Grant](#) provides financial and technical assistance to education organizations looking to advance their farm to school programs.

Vermont Children's Trust Foundation Grants: Applications Due March 17

The Vermont Children's Trust Foundation Grants are for primary prevention programs, serving children ages 0-18. These programs strive to reduce the likelihood of juvenile delinquency, truancy, substance use, child abuse and other socially destructive behaviors before intervention by authorities, through strength-based activities in a community-based setting. CWSRF and DWSRF Plist Applications Due February 25

This is a reminder that the deadline for submitting Project Priority List (PPL) applications for both the Clean Water and Drinking Water State Revolving Funds is February 25, 2021.

Important changes to this year's CWSRF and DWSRF process:

- The priority list deadline is firm. No applications will be accepted after 2/25/2021.
- A project must have submitted a draft preliminary engineering report (PER) in order to be included on a priority list for construction funding. As always, planning funding is available at anytime.

· If you do not have a PER please just submit page one and two of the Priority List Application.

For the CWSRF:

A [Priority List Application](#) must be completed for each existing and new project each year. The completed applications must be submitted via email to ANR.CWSRFplist@vermont.gov.
