CVRPC Seeks Municipal Representatives to CWAC

The CVRPC Clean Water Advisory Committee (CWAC) has openings for municipal representatives and are soliciting interest for serving on this committee where you can learn and provide feedback about the State of Vermont's initiatives, plans, and programs for water quality restoration and protection. Main responsibilities of the CWAC are to oversee programming of CVRPC's assistance to the Vermont Department of Environmental Conservation's Tactical Basin Planning, coordinate water quality related activities with the CVRPC Transportation Advisory Committee, participate in special studies by the CVRPC, and provide input and recommendations to the CVRPC Board of Commissioners. CWAC meetings are held every other month on the second Thursday from 4 – 6 PM both in person and with a

Housing Committee Survey

Housing committees can play an important role in community-based approaches to meeting local housing needs. These groups can be formal municipal commissions, resident advocacy groups, or any other local groups that seek to support or change the quality, quantity, affordability and inclusiveness of housing in a community. Similarly, housing committees can document existing housing stock, assess housing gaps and influence local policy, including zoning changes, permitting processes, the creation of Housing Trust Funds, and others. These local committees can also help improve community understanding about the relationships between housing affordability, equity, and economic vibrancy.

This survey is designed to collect information about existing housing committees in Vermont, identify those wishing to start committees, and to connect you with additional resources to meet your community's housing needs. The data will be used to expand the online Housing-ready Toolbox (https://www.housingdata.org/toolbox/) with success stories, best practices, and resources for existing and new committees.

The Housing-Ready Toolbox was created through partnership of the CVOEO Fair Housing Project's Thriving Communities initiative, the Vermont Department of Housing & Community Development, and Vermont Housing Finance Agency.

RFP's, Grant Information, Applications & Deadlines

FY2022 Grant Funding for Municipal Highway and Stormwater Mitigation

The Vermont Agency of Transportation (AOT) is pleased to announce a funding opportunity to provide financial assistance to municipalities in an ongoing effort to improve the quality of water statewide.

Grants funded through this program must have a transportation link. The enabling legislation that determines eligibility is as follows: "Any environmental mitigation activity, including pollution prevention and pollution abatement activities and mitigation to address stormwater management, control, and water pollution prevention or abatement related to highway construction or due to

highway runoff."

Potentially eligible project types include planning studies (stormwater inventories, low restoration plans, phosphorus control planning), salt/sand sheds, bank stabilization, culvert replacement/resizing, stream bank stabilization, detention ponds, check dam, swirl separators, permeable pavers, infiltration basins, gravel wetlands, subsurface detention systems, bio filters, and bio retention systems.

Eligible applicants for this grant program are municipalities. There is not a program cap on the amount of funding granted to a specific project, though there is a 20% local match requirement. All projects must be developed in accordance with applicable federal and state regulations.

All projects shall be developed according to the guidelines published in the Municipal Assistance Bureau – Local Projects Guidebook for Municipally Managed Projects. Some of the requirements highlighted in the above sources include compliance with the National Environmental Policy Act, Uniform Act for Right-of-Way acquisition, Buy America Provisions, and low bid, sealed bid process for construction (Force Account generally not allowed). This a reimbursement program, and municipalities must submit invoices for completed work to be reimbursed appropriately. All projects must be completed, or all expended federal funds will be required to be paid back.

All applications require a letter of support from their Regional Planning Commission (RPC). Projects located in or adjacent to a state maintained right of way must submit a description of the project and/or plans to the District Transportation Administrator (DTA) in that region. A copy of this correspondence to the DTA must be attached to your application.
