32	Section 502, Elections: M. Gray noted that the Bylaws were clear that nominations from the
33	floor for officers and committees were to be included with the slate proposed by the
34	Nominating Committee. Discussed Roberts Rules of Order and write in candidates. Concluded
35	write in candidates are permissible on a ballot.
36	 Section 503, Elections: M. Gray noted the bylaws were clear on what happened for nominations
37	from the floor.
38	 Section 601, Meetings: Added language to enable meeting via telephone or through use of
39	Internet meeting services while maintaining compliance with Vermont Open Meeting Law.
40	 Section 705, Signatory: Discussed staff recommendation to add language to authorize the
41	Executive Director or the Director's designee to approve and sign funding applications and
42	proposals. This is CVRPC's current practice. The language adds clarity for certain federal grant

1	applications. Included direction that Board authorization for a specific application or proposal
2	when required by a funding agency be obtained in advance of the application submission.
