# **ARPA CSO funding for Northfield and Montpelier**

The first four municipalities selected for these awards were the highest-scoring projects in the 2022 Pollution Control Project Priority and Planning List; a process the State uses to award infrastructure grants as well as loans. Municipalities with existing CSOs and municipalities where CSOs have been abated but additional work remains are also eligible for funding and the State will be soliciting applications to the "Priority List" to inform the need for additional appropriations during the upcoming legislative session. These grants will complement existing local and state funding sources. Montpelier and Northfield were two of the municipalities selected.

### RFPs, Grant Information, Applications, and Deadlines

The Lake Champlain Basin Program seeks proposals for projects that support local watershed groups and provide opportunities for informing and involving the public in Lake Champlain outreach initiatives in the Lake Champlain watershed. The Program anticipates awarding up to \$240,000 to local organizations, municipalities, and educational institutions.

Current grants will be awarded in the following categories:

Organizational Support – small grants (up to \$4,000 per award)
 Education and Outreach Implementation grants (up to \$15,000 per award)

AOT Announces Funding Opportunity for Municipal Road Proje

The Vermont Agency of Transportation (AOT) announces the 25th year of funding to support

projects on municipal roads that improve water quality and result in maintenance cost savings. The grant funds are provided by AOT in partnership with the Vermont Agency of Natural Resources. The Vermont Better Roads Program promotes the use of erosion control and maintenance techniques that save money while protecting and enhancing water quality around the State.

The application scoring of the Better Roads Program is intended to be in line with the State's Clean Water Act (Act 64) and the Municipal Roads General Permit (MRGP). In an effort to prioritize funding for projects that provide significant water quality improvements, applicants must indicate whether or not the projects that they intend to construct will be in full compliance with the MRGP. Please see application and scoring sheet for more information. If you have questions, please feel free to contact Better Roads staff.

**Applications for funding will be accepted until December 17, 2021**. Funding will be awarded after the legislative appropriations process, which is expected to be July 2022.
