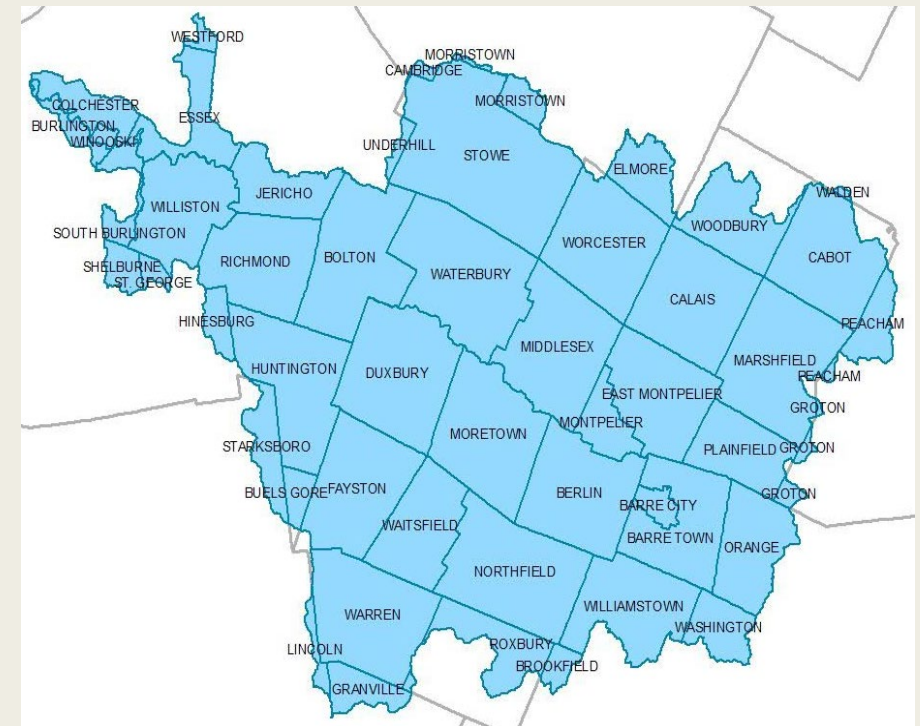

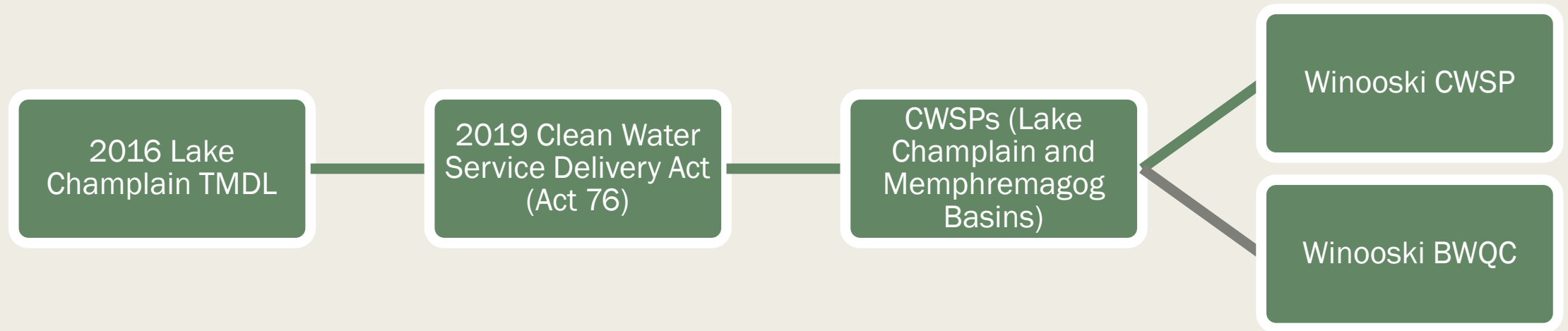

Clean Water Service Delivery Act of 2019

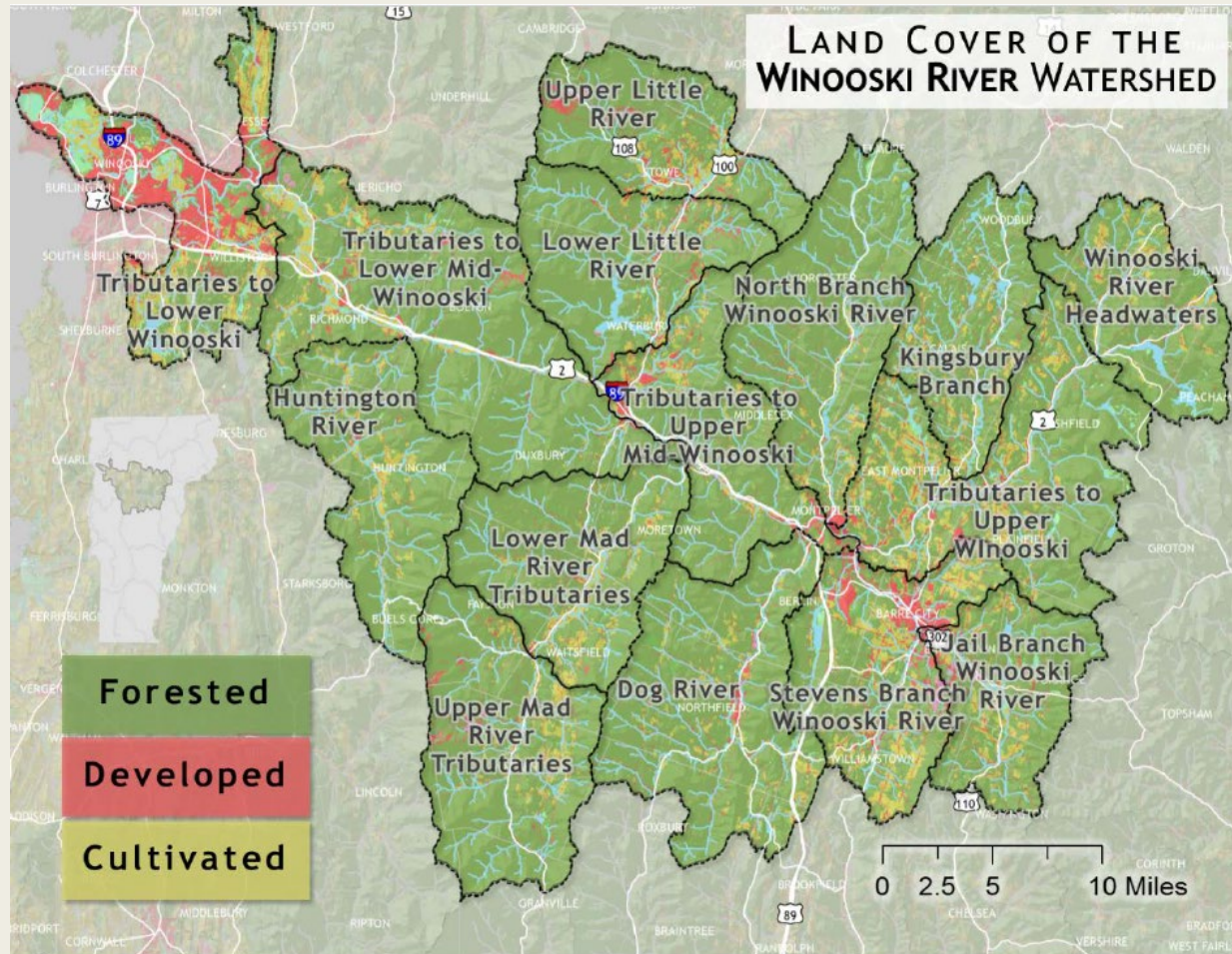
- Establishment of a network of decentralized Clean Water Service Providers (CWSPs) for watersheds in Lake Champlain and Lake Memphremagog basins
- CWSPs provide "*boots on the ground*" project delivery for non-regulatory clean water projects to achieve pollutant reduction targets
- CVRPC is the CWSP for Winooski Basin

Non-Regulatory Clean Water Projects Examples

- Small scale stormwater management practices
- Natural resource restoration projects (floodplain reconnections, wetlands restoration, vegetated buffer planting)
- Forestry or agricultural projects

Basin 8 Quick Facts

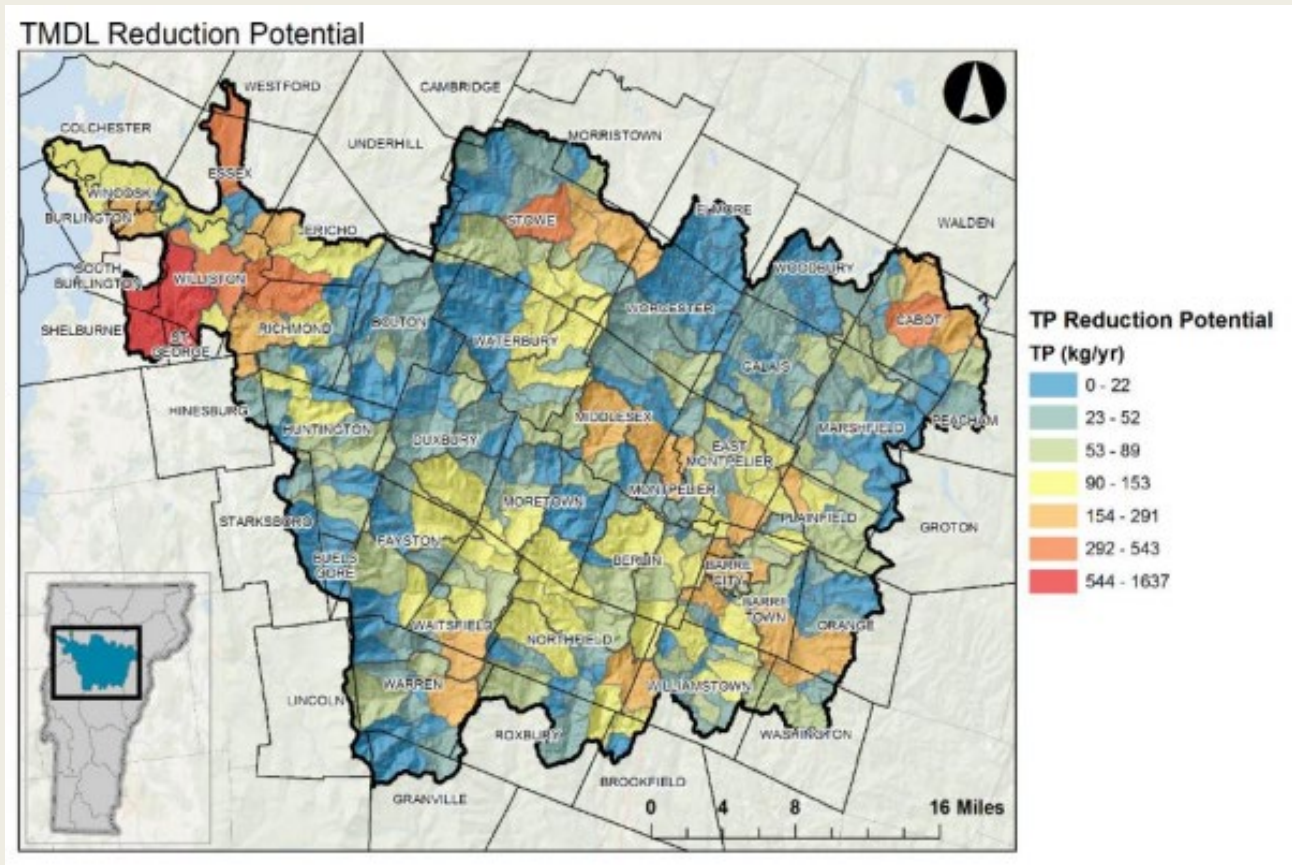
- 7 main tributaries, drainage area covers almost 12% of state
- 50 municipalities and 6 counties
- 76% forested, 10% agricultural, 8% urban

Basin 8 Pollution Reduction Targets

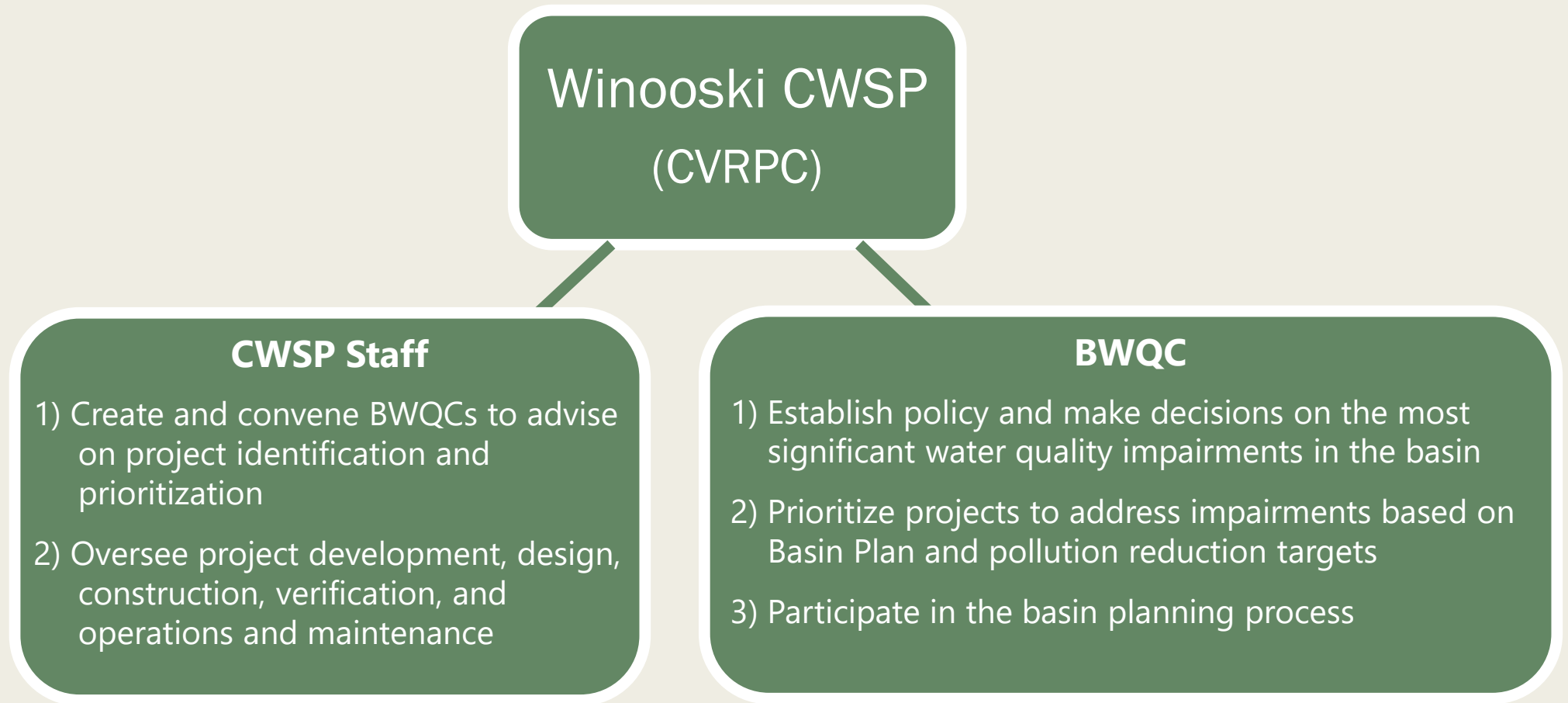
- Sources of phosphorus pollution
 - ✓ Agricultural (non-RAP farms)
 - ✓ Developed land (roads, parking lots)
 - ✓ Forested land
 - ✓ Streams are highest reduction target
- Winooski Basin contributes ~25% of VT's Lake Champlain phosphorus load

Proposed Phosphorus Reduction
Year 1 = 95 kg/year

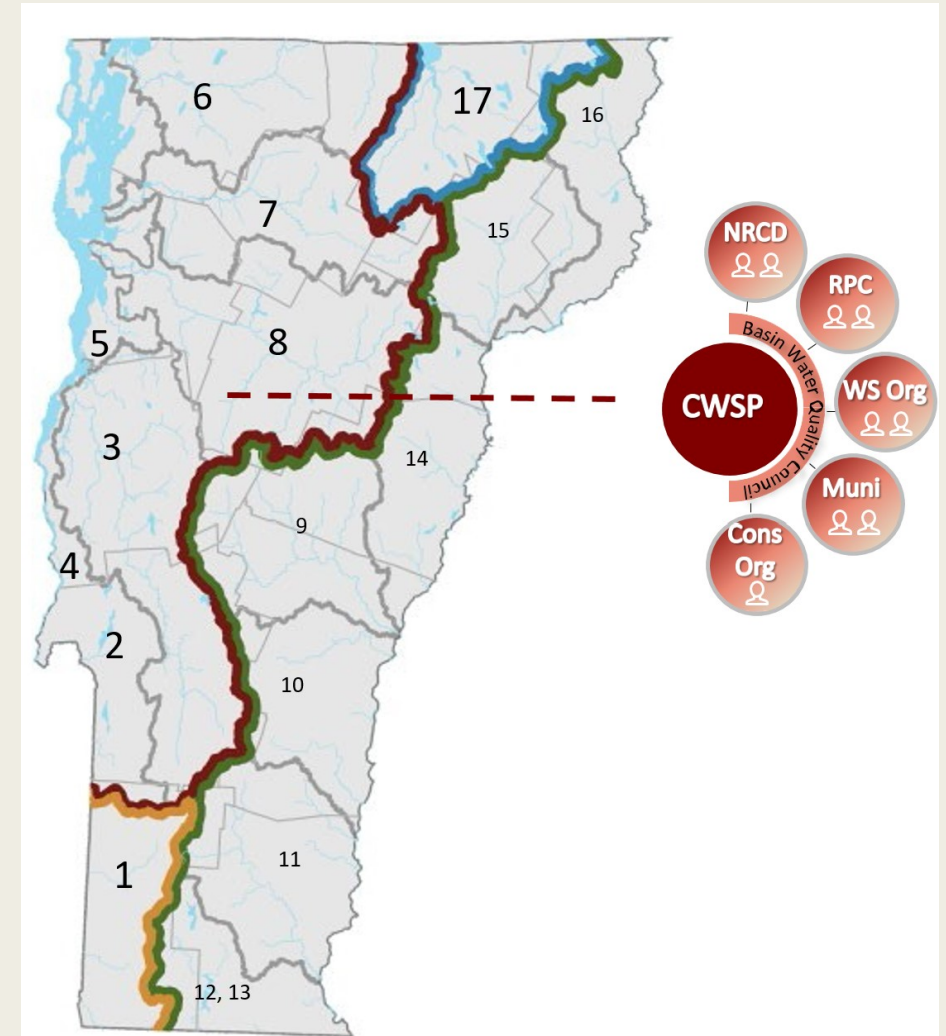
CWSP Structure

- (2) Members from Natural Resource Conservation Districts (NRCDs)
- (2) Members from RPCs
- (2) Members from watershed protection organizations
- (1) Member from local/statewide land conservation organizations
- (2) Members from municipalities in the basin

BWQC Member Qualifications

- **Knowledgeable** on clean water topics for the basin,
- **Acts in good faith** in the discharge of BWQC duties, and
- **Available** to participate in at least four meetings per year

Additional qualifications for local watershed protection organization members:

Associated with a community-based nonprofit that:

- works with individuals and communities
 - to protect and improve water quality, habitat, and flood resilience
 - to connect people with Vermont's waters
- is open to all watershed constituents
- does not represent a specific constituency or interest group
