ARPA Final Rule Updates - CVRPC Assistance Available

You may be aware that US Treasury released the Final ARPA Rule on January 6, 2022 (overview <u>found here</u>) which guides the use of ARPA funds. It contains many changes, but the largest one is related to revenue loss.

The Final Rule allows municipalities to determine the amount of revenue lost due to the pandemic *either* according to a formula or by claiming a standard allowance of up to \$10 million (for the entire performance period). VLCT analysis suggests this means municipalities can now claim their entire ARPA award as revenue loss and use it for the provision of government services.

Proposals Requested for Transportation Planning Services and/or Studies

Central Vermont Regional Planning Commission is requesting proposals for transportation planning studies to be completed during the spring and summer of 2022. Help us make getting around easier, safer, and more convenient for everyone by contributing your ideas. Proposals are due **March 8, 2022.**

CVRPC will complete transportation special projects and studies using funding from the Vermont Agency of Transportation's Transportation Planning Initiative. Project work will need to be completed between May and September 30, 2022, therefore limiting the scope of work that can be completed in this short time. Project estimates should not exceed \$30,000 without prior staff coordination. Inter-municipal and regional projects will be prioritized. These funds are meant to facilitate planning that will help shape future capital improvements; however, we are unable to fund construction directly.
