Now in its sixth year, the grant program is part of AARP's nationwide Livable Communities initiative, which supports the efforts of cities, towns, neighborhoods and rural areas to become great places to live.

State Transportation Innovative Council Incentive Awards Available

Do you have any innovative project ideas that could benefit VTrans? This year, the Vermont State Transportation Innovation Council (STIC) is focusing on projects that address:

- · Climate adaptation strategies that bolster the resilience of our infrastructure
- · Ways to increase the involvement of underserved communities in the transportation decision-making process

You have the opportunity to secure up to \$100,000 in Federal funding for your project by submitting a <u>STIC Incentive Award Application</u>. The STIC Incentive program supports or offsets the costs of standardizing innovative practices. Projects should have an AOT Champion and applicants should suggest sources for a 20 percent match.

Applications will be reviewed by the STIC Executive Team, who will base their award selections on a project's alignment and fit with VTrans and FHWA goals and priorities. Visit the VTrans STIC website for more information and the application.

Funding Available to Respond to Opioid Overdoses

The U.S. Department of Health and Human Services (HHS) First Responders Comprehensive Addiction and Recovery Act Grant Program is offering up to \$250,000 to provide resources to first responders and members of other key community sectors at the state, tribal, and other government levels to train, carry and administer Federal Food, Drug, and Cosmetic Act (FD&C Act) approved drugs and devices for emergency reversal of known or suspected opioid overdose.

Applicants must demonstrate that their population of focus is underserved as demonstrated by a lack of accessibility to treatment providers, emergency medical services and recovery and other psychosocial support services. Funding recipients will be expected to establish processes, protocol, and mechanisms for referral to appropriate treatment and recovery support services and safety around fentanyl, carfentanil, and other dangerous and elicit drugs.

Eligible applicants include state governments, and local government entities including municipal corporations, counties, cities, boroughs, incorporated towns, and townships. No match is required.

Applications for First Responders-Comprehensive Addiction and Recovery Act Grants are due April 5, 2022.

Free Communities (DFC) Support Program is offering up to \$125,000 to fund work focused on establishing and strengthening collaborations among communities, public and private nonprofit agencies, as well as federal, state, local, and tribal governments to support the efforts of community coalitions working to prevent and reduce substance use and misuse among youth.

Competitive applicants should address the factors that increases the risk of substance use and misuse among youth and adults such as lack of parental involvement and accessibility of substances. They should also promote the factors that minimize the risk of substance abuse including community intervention and education.

DFC recipients are expected to collaborate with organizations and leaders in their communities to identify and address local youth substance use problems. They should also work to create sustainable community-level change through the implementation of evidence-based and practice-based prevention strategies.

Eligible applicants are community-based coalitions that have not yet received a DFC Grant. They include 501(c)(3) nonprofit organizations, states, counties, cities or townships, special district governments, independent school districts, private and public institutions of higher education, and Native American tribal governments and organizations. A 1:1 match is required. Beginning in year seven, the percentage of match increases to 125%, and increases to 150% in year nine.

Applications for the Drug-Free Communities Support Program are due by April 11, 2022.
