ARPA/SLRF Permitted as Local Match for VTrans Municipal Assistance

After a lot of back and forth between VTrans, FHWA and VLCT it has been decided that funds provided to the municipalities under the revenue loss provisions of State and Local Fiscal Recovery/American Rescue Plan Act (SLRF/ARPA) may be used as the local match on projects awarded through VTrans Municipal Assistance. If you do choose to use SLFR/ARPA funds for your local match your municipality will need to ensure the expenditures are properly accounted for and that all Treasury Department rules associated with those funds are being adhered to.

New certification language will need to be added to invoices submitted to VTrans.
