June 30, 2022 | 12:00 - 2:00 pm



Community Cooling Facility Web Map

With hot weather upon us again, the Vermont Dept. of Health has rolled out a new web map for community cooling locations. The map lists facilities by type (ex. pool, library, city hall, church) and contains contact information, hours of operation, and whether there is an entrance fee. Workshops for Municipal Staff Moving Trees

Safe Tree Removal Training for Municipal Staff is a hands-on workshop led by Montpelier City

Arborist Adam McCullough focused on using ropes to safely guide trees to the ground while keeping workers out of the strike zone. Participants will leave with skills necessary to use this technique in their communities. The first six municipal registrants in each workshop will also receive a rope-throwing kit with the lines and throw weights needed to throw ropes with their crews. The workshop will be held in two locations – attendees should register for just one: 8amnoon on July 20th in Burlington or 8amnoon on July 21st in Montpelier. Registration required; \$25 for a single attendees, \$40 for a team of two or more attendees from a single municipality. Vermont Local Roads Scholar credits available.

Tree Risk Evaluation Training for Municipal Staff and Volunteers focuses on common tree health conditions that should factored into any assessment of tree risk in public places. Join Burlington City Arborist VJ Comai on July 20th from 1pm-4pm in Burlington **OR** State Forest Health Specialists Jim Esden and Savannah Ferreira on July 21st from 1pm-4pm in Montpelier. Opioid Settlement Committee Application

The State of Vermont anticipates receiving \$63 million over 18 years as a result of a settlement with three pharmaceutical distributors and one manufacturer. Act 118 establishes an Opioid Settlement Advisory Committee to advise the Department of Health how to spend the funds. The committee will consider the impact of the opioid crisis on communities, abatement strategies, the perspective from opioid use disorder prevention coalitions, and challenges to marginalized populations. Members will serve four-year terms. Seven of the 16 members will be local officials appointed by VLCT. FY23 Building Communities Grants Program

he Building Communities Grants Program has been funded for FY2023 and with increased funding! This program, administered by BGS, includes the following:

- 1. \$300,000.00 Recreational Facilities Grant Program
- 2. \$300,000,00 Regional Economic Development Grant Program
- 3. \$150,000.00 Human Services Facilities Grant Program
- 4. \$150,000.00 Educational Facilities Grant Program



These grants are for construction and capital improvements to support and strengthen Vermont towns and regions. Descriptions, the application criteria, and the new deadline for all four of these grant programs are available on the <u>Department of Buildings and General Services website</u>. Click on the program area above to see the projects funded last round.

Applicants including municipalities, nonprofit agencies, and regional economic development organizations, are all encouraged to apply for these opportunities to fund construction, infrastructure support, and needed projects.

Although the award of the grants is competitive, the application process has been designed to be simple and straightforward. Grant applicants will be awarded funding as determined by a special committee comprised of Vermonters, legislative branch members, and executive branch administrative staff appointed by the Governor. Grants recipients will be awarded in the fall of 2022. The deadline has been moved from July 3£^t, to September 10th!

Manufactured Housing Communities Infrastructure Funding

VT DEC is requesting applications for water infrastructure assessments or projects in Manufactured Housing Communities (MHCs). Funding is available for four project types at varying maximum funding allowances: Drinking Water, Wastewater, Stormwater, and VT DEC Stormwater Program 3-acre permit compliance for 3-acre sites. Assistance is available to Vermont Agency of Commerce and Community Development registered MHC only when a need or suspected need for drinking water, wastewater, stormwater, or drainage infrastructure improvements exists.

MHC must be represented by a business, non-profit, or registered cooperative. Individuals are ineligible for funding. Owners, residents, or partners can fill out the application on behalf of the MHC. Organizations or individuals separate from an eligible applicant are able to complete an application as proxy with the authorization of that eligible applicant.
