A. Arrand moved to recommend affirmative determination of energy compliance for VISION FOR THE FUTURE 2021 TOWN PLAN WOODBURY, VT and J. Ohlsson seconded. All in favor, motion carried.

i. J. Ohlsson of Calais notes similarities in common issues that both Calais and Woodbury face. Especially in terms of public transportation. She suggests that Woodbury and Calais work together on public transportation as well as housing issues based on the towns' proximity to each other. M. Gray is open to the idea of working with Calais. Woodbury does not currently have an energy committee but have been discussing forming one to assist with town hall renovations. J. Ohlsson asked how Woodbury was using their ARPA money and noted that the town plan mentioned challenges with water and wastewater. M. Gray: Woodbury has an ARPA committee. Woodbury is aiming for a Village Center Designation and has started discussion about water and wastewater solutions. They plan on using some ARPA funds and Municipal Planning Grant for a feasibility study.
