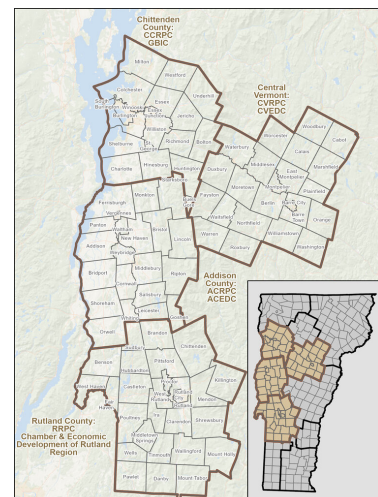

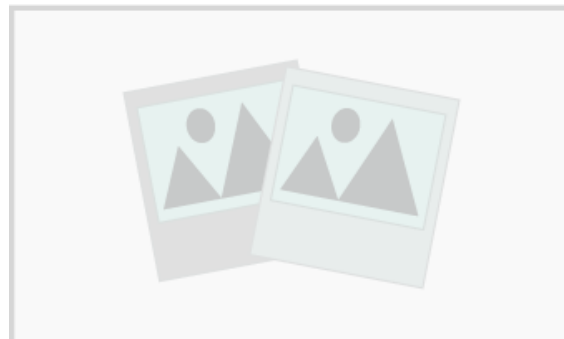

Downtown and Village Center Revitalization Awards

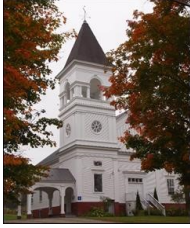
Congratulations to Waitsfield, Warren, and Waterbury for their efforts to revitalize their downtowns and village centers! The Department of Housing and Community Development (DHCD) announced awards of over \$2 million in Downtown Transportation Fund (DTF) grants to support 15 projects in Designated Downtowns and eligible Designated Village Centers. The grants support investment in public infrastructure through the [Downtown Transportation Fund](#). The program has helped update streetscaping, parking, rail, and bus facilities, bicycle and pedestrian safety, utilities, street lighting, and wayfinding signage. Waitsfield was awarded \$19,040 to install of rapid flashing beacons at the Waitsfield Elementary School crossing on Route 100 in the village. This is the first phase of a larger project to improve pedestrian safety at crosswalks along Route 100. Warren was awarded \$114,312 to improve safety for pedestrians and cyclists with changes to slow vehicular traffic in a busy area in the village center. The project will narrow roads with medians and landscaping features, making bridge and crosswalk improvements, and improving road striping and lighting. Waterbury was awarded \$200,000 to upgrade deteriorated and narrow sidewalks on streets adjacent to Main Street, making them wider and accessible to all, while improving the overall safety for pedestrians. Additional enhancements include new lighting, flower baskets, and trash receptacles. The Vermont Division for Historic Preservation is pleased to announce the 2023 round of matching state grants. Funding of up to \$20,000 is available to non-profit organizations and municipalities for work on municipal buildings, historical society buildings, granges, churches, town halls, opera houses and other historic structures.

- Roofs
- Structural elements
- Foundations
- Windows
- Other important components of historic building

VTrans Mobility and Transportation Innovation Grant Program

The Vermont Agency of Transportation is now accepting grant applications for the FY2023 Mobility and Transportation Innovation Grant Program. The program is designed to support innovative strategies and projects that improve mobility and access to services for transit-dependent Vermonters, reduce the use of single-occupancy vehicles, and reduce greenhouse gas emissions. Zoning Bylaw Modernization Grants for New Homes and ‘Great Neighborhoods’

The Vermont Department of Housing and Community Development (DHCD) is pleased to announce up to \$650,000 in available funding to support [statewide municipal bylaw modernization grants](#) for Vermont’s cities and towns.

Municipalities can use this new and innovative funding to hire regional planning commission or consulting staff to collaborate with local stakeholders and prepare bylaw updates that expand opportunities for new homes, confront the State’s housing crisis, and ready communities for unprecedented investments in housing and infrastructure.

The grants support access to the State’s Neighborhood Development Area designation through implementation of the [Zoning for Great Neighborhoods](#) Guide. An initiative that produced model regulations designed to make little zoning updates that have a big impact much easier for local planning commissions, selectboards, and city councils. The project also looked at case study communities across Vermont, revealing a clear mismatch between Vermont’s need for smaller homes and the current zoning regulations – many of which were adopted using mid-century templates favoring single-household homes, large lots, and expensive infrastructure.
