CWSP Policy Updates

- 1) Procurement / sub-grant guidance- BWQC to review
- 2) Public engagement/participation BWQC to review
- 3) Records retention
- 4) Internal controls incl. dissolution, accounting, financial management, etc.,
- 5) Personnel policy incl. discrimination language that complies with federal / state law
- 6) BWQC bylaws BWQC to co-write/review
- 7) Conflict of interest

CWSP Policy Updates: Procurement

- ♦ Small purchases
 - ♦ CVRPC threshold: \$3000
 - ♦ CWSP threshold: \$1000 (quote required for purchases > \$1000)
- ♦ Procurement > \$10,000 require a contract
- Procurement > \$15,000 from a single vendor requires contract
- Procedures:
 - vendors solicited should understand they will be required to sign an agreement that includes provisions of the formula grant that are required to passed onto subcontractors / subgrantees, together with other applicable requirements
 - BWQC members may not participate in procurement decision making
 - CWSPs alone are responsible for procurement under the formula grant

CWSP Policy Updates: Procurement

- Pre-qualification & Sole Sourcing
 - Pre-qualification process must be open at least once per year
 - Typical categories of services that a CWSP might seek pre-qualified entities for include engineering, project management, and construction, among others
 - ♦ Sole Source subawards are allowed when an entity has been prequalified to provide services pursuant to § 39-306(h)

CWSP Policy Updates: Records Retention

- Procurement of Goods
 - Records related to the procurement of services shall be retained for the term of the contract plus three years
 - Records related to procurement of goods shall be retained for at least one year after the audit covering the procurement
 - Records related to procurement of services shall be retained for at least three years after the audit covering the procurement
 - Records relating to the RFP/bid process, including proposals and a record of the selection process, shall be retained in the contract/grant file in accordance with the CWSP's records retention schedule
- CVRPC Records Retention Policy was shared with (Vermont State Archives & Records Administration (VSARA) for their review & feedback

CWSP Policy Updates: Internal Controls

- Principal Director
 - one principal Director (CWSP Director), who shall be responsible to the Secretary for the entity's compliance with all CWSP obligations set forth in statute, this Rule, and guidance
 - authorized signatory for all CWSP activities
 - review & approve CWSP budget + monitor CWSP financial status
- Separation of duties
 - 1. custody of assets & accounting
 - 2. authorization of use of assets
 - 3. reconciliation
- Other topics: financial reporting, safeguarding of assets, insurance, dissolution

CWSP Policy Updates: Personnel

- Personnel practices, policies, and procedures that promote high quality services
- Policies prohibiting discrimination based on all protected classes under federal and Vermont state law
- Maintain evidence showing that the CWSP adheres to its stated practices
- Detail separation of duties, approvals/authorizations, and safeguarding of assets

CWSP Policy Updates: Conflict of Interest

- All persons engaged in the decision making of the respective CWSP or BWQC, or both, shall conduct themselves according to high ethical standards
- * "Conflict of interest" means an interest, direct or indirect, financial or otherwise, of a person or entity with a CWSP or BWQC decision making role, or such an interest, known to such person, of a member of that person's immediate family or household, or of a business associate, in the outcome of a particular matter pending before the CWSP or BWQC or which is in conflict with the proper discharge of the person's duties under this Rule
- A person engaged in CWSP decision making must disclose any potential conflict of interest and shall recuse itself from any CWSP decision making subject to that conflict
- ♦ A BWQC member that proposes to implement a clean water project must disclose any potential conflict of interest and shall recuse itself from any BWQC decision making subject to that conflict. Notwithstanding these limitations, the conflicted BWQC member may answer questions on the subject project in an open meeting of the BWQC
- It is recommended that CWSPs should require every subcontractor / subgrantee to disclose in writing any actual or potential conflict of interest
