Meeting Summary

February 08, 2023

Welcome and Introductions

The meeting convened at 5:05 pm. A quorum of voting members was not present, and no formal action was taken during the meeting. All members in attendance introduced themselves and the community they represent. An adjustment was made to the agenda to give time to Evelyn O'Hara-Short the new VDH Public Health Specialist for Emergency Preparedness.

Presentation: National Weather Service

Scott Whittier-Warning Coordination Meteorologist explained the National Weather Service (NWS) role in Emergency Planning and Response. He gave statistics of a damage and fatalities from a typical year within the US. Their support of VEM in creating realistic scenarios for exercises and the role they play in SEOC support. Provided examples of multiple page briefings for situational awareness for weather events. He also walked through their website and demonstrated all the different reports that can be accessed. Hot weather, cold outlook, snowfall totals, many options and forecasts that are updated every three hours.

Notified the group of the NWS ability to support large events. Not able to provide for a specific venue but are able to provide this service for municipalities or public safety members (fire chiefs, police, EMS, or local planning commissions. They will create a threat matrix and give direct notifications the day of event if weather outlook turns bad. They need this service to be requested at least two weeks prior to this event.

Evelyn O'Hara Short-Gave a brief introduction of her program and opportunities VDH offers. She explained her role in the medical reserve corp. and what they offer. Gave example of vaccinating migrant workers on a local dairy farm. VDH is here to help and provide assistance-networking. REMC Overview, Initial Work Ideas

Keith Cubbon reminded the members of the upcoming LEMP cycle that begins with town meeting day. This created a conversation about vulnerable populations which Harry Schoppmann answered. He explained VEM is looking for daycares, nursing homes, facilities that may need help in evacuating and that they also need a point of contact listed. Also, the CARES program list was discussed with Betty Copeland explaining that home health aides offer information on this as part of their signing up new patient's process.

Betty also informed the group about 211 service not working for AT&T First Net service. She has already been in contact with regional representative. Harry asked that she send him the information that she had on it and he would look into it since VEM would be concerned about a lack of access to the 211 system. Betty announced to the group that Calais will be hosting a Red Cross Shelter Fundamentals on March 18 from 10-12:30 with the location still yet to be determined.

VEM Updates

Stefan asked Harry about Narcan availability. Harry said he would forward information for Stephanie Bush and how to access both Narcan and training for it. He also answered a question about how the VEM is addressing quorum for REMCs. He explained that they are trying to get a change from the legislature that would allow each REMC to define what quorum means to them. Chris Violette asked Harry if the 8 hr EMD course would be recorded, Harry replied that it isn't because of the need for back and forth discussion but it will be offered three times this year. Jeff Campbell asked about 402 training for elected officials, Harry replied it will be offered in May.
