## Worcester Activities Through June 30, 2023 (Fiscal Year 2023)

- Prepared and submitted Emergency Relief Assistance Fund information to town to facilitate elevated disaster relief aid.
- Facilitated discussions with town on opportunities for technical assistance under the Municipal Technical Assistance program (MTAP).
- Assisted in the Village Center Designation application process and updated village center map.
- Met with planning commission chair to discuss possible bike and pedestrian scoping study for pedestrian access in village and town.
- Provided information and assistance on town plan adoption process and recommended next steps.
- Provided technical analysis, coordinated with utility, industry, school and public on fuel-switching and onsite generation and storage project development.
- Successfully completed application for municipality for \$4,000 to complete energy related engagement and outreach. Facilitated applications for energy assessments for town hall, town office/fire department complex, and town garage.
- Provided guidance on Enhanced Energy Plan development process and strategic coordination of plan development and energy programs participation.
- Provided information on funding opportunities, programs, incentives for wood heat and EV charging.
