Approval of January 2024 TAC Meeting Minutes

Robert W. made a motion to accept the January meeting minutes with Bob A. as 2nd.
Group voted and motion passed

Review of Updated Transport Chapter Goals

- David E. wanted stronger verbiage than "encourage" and "promote". Proposed use of "expect" equitable outcomes. Proposed change of "elderly" to "older persons". Prioritize complete streets. Change references from bikers to "cyclists"
- Bob A. wanted stronger language in goals by dropping qualifying verbs
- Joyce M. felt that item 4.c should be rephrased to focus on resilience, or moved under goal 1 (or possibly 3)
- Alan Q and Bob A wanted an electric vehicle specific focus under goal 3 "environment and climate"
 - Ron K pointed out that electrifying emergency vehicle fleets would require creation of Level 3 municipal chargers
 - David E expanded this by referencing the need for upgrades to transmission infrastructure
 - It was noted that Grid upgrades are dealt with in depth in the Energy and Infrastructure Chapters
 - Joyce M mentioned the role of VELCO in statewide grid planning efforts and raised concern about congestion mitigation as an environmental strategy (because it often entails increased capacity/throughput/volumes)
 - Alice P wanted language in 3.b changed for easier comprehension
 - Dan L called attention to the need for industry standardization of chargers as compatibility issues a challenge to EV infrastructure adoption and vehicle adoption

Discussion of Planning and Project Priorities in Absence of New VPSP2 Projects from State

- Mike H asked about possibly studying Exit 10 interchange, specifically Northbound. Off ramp queueing back onto travel lane from signalized intersection with Rt 100
 - Reuben indicated that the viability of any I-89 related work would require coordination with AoT and FHWA
- Alan Q expressed frustration at the chapter lacking climate change goals
- Alice P would like to see efforts directed toward bike/ped improvements
