Washington Activities Through June 30, 2024 (Fiscal Year 2024)

- Met with town planning commission, provided technical assistance in municipal plan update, and shared relevant information and resources.
- Inventoried all bridges and culverts on town highways (20 bridges, 322 culverts), and uploaded information to state data viewer.
- Provided introduction to Act 174 standards and updates and integration of enhanced energy planning into broad town plan and planning for municipal leadership.
- Engaged with Washington representatives on the VT Urban Community Forestry Community Tree Planting Grant and offered grant administrative assistance.
- Facilitated and attended Energy Assessments of the Municipal Building and Calef Memorial Libraryprovided assessment workflow and technical assistance throughout as part of the Municipal Energy Resilience Program (MERP). This assistance directly led to the award of \$77,351.30 in FY 25 Implementation Phase funding.
- Provided guidance and assistance on FEMA processes for registration and reporting for July 2023 flood (DR-4720).
- Reviewed town Local Emergency Management Plan and submitted for State approval.
- Provided resources and support for the adoption of River Corridor Bylaws to increase town Emergency Relief and Assistance Funding.
