- VII. Approval of Meeting Mintes for 05/21/2025
 - a. Motion was made by E. Metivier to approve July 21, 2025, minutes, seconded by J. Campbell. With no discussion, July 21, 2025, minutes were approved by a majority of the body.
- VIII. Approval of Treasurer report
 - a. S. Bagg presented the treasurer's Report. S. Bagg reported that CFMA ended the fiscal year in the black due to a decrease in operational expenses. The Capital Replacement underperformed due to not having Chelsea onboard, which we were planning on. The CDs interest came in twice the amount that was anticipated. S. Bagg apologized for getting dispatching invoices out late. J. Aldsworth asked for an update on the financial review. It was mentioned that CFMA was changing to a different accountant and that the review is still in progress. Motion was made by J. Campbell to approve the Treasurer's Report, seconded by E. Metivier. With no discussion, July 2025, treasurer's report was approved by the majority of the body.

IX. Old Business

a. Update / discussion - Communication Project I've been meeting with Keith and we're ready to get a draft together which we will present to the communications committee for funds. A copy of a map with 17 site system simulcasted that is P25 capable, but it will remain in basic mode until we're ready to pull that trigger. Basically, the time frame is, we will submit our application at the end of next week. Then they will review it, they'll open it for discussion and then they will make their final selection of where it goes forward and then the third week in August. We can do a special meeting of capital fire so that everybody can hear exactly what the engineers have come up with. My

recommendation is we have a special meeting, and you hear exactly what the projections are going to be. P. Cerutti made the motion for a special meeting, seconded by Roxbury. Any discussion? Motion passed. 90% of their system should be microwave. They are shooting for 100% but there are a couple holes. They're just not going to be able to get to 1 of the sites that is probably Norwich University. But they haven't counted that out yet. The state is becoming inactive partner in this. They're reluctantly coming forward. We have a presentation coming to the task force of the update on our project. They're pretty interested in hearing about where we're at. There has been no movement on the Municipal grant to both cities, Mad River and Barretown to figure out how to move forward with the dispatching services they are working to get that. Part of the grant request is going to be incorporating the CAD system. We have heard back from Motorola, and they do have a project product that can merge with Valcour to do exactly what we need to do. They're still working on the funding and that's why I thank you guys for getting back to me. Motorola extended potential savings for two budget cycles for portables, mobiles and pagers of a 40% discount. That means in your budget you should start thinking about replacing your portables and radios. This is for Motorola products.

b. Accountability Tag Update – G. Dillon - Looking for clarification or consideration for conversation about the colors of the tags. The difference from what we put forth in the policy, versus what NFPA recommends is different. Discussion was had. Motion to change the colors to follow NFPA standards. The motion was made by W. Schwarz, second J. Quinn. Motion passed by the majority of the body. The ordering of extra or replacement tags will be on the individual departments.

X. New Business

- a. Mayday SOP J. Aldworth asked if the working group would take on a CFMA Mayday SOP. There was discussion about how that may come about. The written policy/SOP and then training.
- b. R.I.T. H. Knott shared, Chief Todd Smith, Rochester, NY, has a proposal here for two-day program, approximately \$95 a student, 20 students in the class, at approximately \$1,900. That is referring to NFPA 1407. We also have another resource, Chief Mike Gallis, his cost is coming in at \$1,300 broken down for two instructors and \$100 course fee and that's with the two instructors you're looking at a course for 25. Both the Mayday and R.I.T. working groups will work together.
