



# Central Vermont Regional Emergency Management Committee

## Meeting Summary

May 13, 2026

### **Welcome and Introductions**

The meeting opened at 5:04 pm.

There were no adjustments to the agenda.

A quorum of voting members was present.

Keith announced that there are possible grant funding sources for AED machines. He also spoke to FEMA, being funded again at the by congress and that the Emergency Management Planning Grant which funds CVRPC's work may be arriving soon which would help us to better support the towns and EMDs.

**Minutes:** A motion was made to adopt the February minutes. The motion was made by Eric Metivier with Michael Billingsley as 2<sup>nd</sup> voting commenced and motion passed.

### **Hazard Mitigation Funding Update**

The Vermont State Hazard Mitigation Officer provided a comprehensive update on state and federal hazard mitigation activities, including:

#### **FEMA Hazard Mitigation Programs**

- Overview of recent FEMA Hazard Mitigation Grant Program (HMGP) funding rounds following the 2023 and 2024 flood events.
- Discussion of buyout projects and infrastructure mitigation proposals submitted statewide.
- Explanation that Vermont submitted more eligible projects than available federal funding could support.

### **Project Tracking and Coordination**

- The State developed a "Master Unfunded Tracker" (MUT) list to organize and monitor mitigation projects that have not yet secured funding.

- Regional Planning Commissions are reviewing and updating project lists with communities.
- Emphasis was placed on maintaining project readiness for future funding opportunities.

## **Buyout Program Status**

- Approximately 252 FEMA buyout projects have been submitted statewide.
- Roughly 139 projects have reportedly received awards.
- Many projects from the 2023 flood cycle are progressing toward completion, while newer 2024 projects remain under review.

## **BRIC Program Changes**

Discussion focused on significant changes to FEMA's Building Resilient Infrastructure and Communities (BRIC) program:

- Funding opportunities are more limited than in previous years.
- Project scoping remains eligible but now needs to be more than 30% to be funded by FEMA for implementation.
- Local Hazard Mitigation Plan development is no longer eligible under BRIC.
- FEMA has eliminated phased implementation projects.
- Future implementation projects will need to be substantially complete and "shovel ready" to remain competitive. Towns will need to have to have engineering complete to be ready.

## **Community Preparedness and Planning**

- Communities were encouraged to continue developing mitigation concepts and infrastructure proposals.
- Officials stressed the importance of advancing engineering and design work before future federal funding rounds open.
- Discussion included match requirements and funding considerations for economically disadvantaged communities.

**LEPC Update-** Jeff Campbell gave an update.

Group met in April. They have been seeing an increase in attendance especially from the industrial/commercial sector. They did an abridge lithium-ion battery class that they are beginning to offer for non-fire department organizations.

**VEM update-** Michaela Foody gave the update as Sid Pollock was unavailable.

Derek Libby mentioned he had heard that the Berlin armory is the current back up during the construction. Stefan requested a review to see if a different time or day of the week would be better for the meetings. The next meeting is anticipated for August 12, 2026, pending confirmation through a scheduling poll.
