



REGIONAL PLAN PUBLIC HEARING NOTICE

Notice is hereby given by the Central Vermont Regional Planning Commission of the Public Hearing to be held for the purpose of gathering comments on the draft CVRPC 2026 Regional Plan and the Regional Future Land Use Map. This hearing shall be the first of two hearings required under 24 V.S.A. § 4348.

The Central Vermont Regional Plan covers the following municipalities: Barre City, Barre Town, Berlin, Cabot, Calais, Duxbury, East Montpelier, Fayston, Marshfield, Middlesex, Montpelier, Moretown, Northfield, Orange, Plainfield, Roxbury, Waitsfield, Warren, Waterbury, Washington, Williamstown, Woodbury, and Worcester.

The purpose of the Plan is to support coordinated, efficient, and equitable development in the Region. Once approved, the plan will also be used as regulatory review criteria in Act 250 and Section 248 proceedings.

To meet the 12/31/2026 deadline for an adopted and approved regional plan, the proposed Plan is largely a revision of the 2024 Plan. To meet new statutory requirements, the most substantial edits were made to the Future Land Use chapter, including a new Regional Land Use Map, the Housing chapter, and the addition of an environmental justice analysis.

Specific feedback is welcome on how the draft Plan conforms to the state planning goals in 24 VSA Section 4302, the energy compliance requirements of 24 VSA Section 4352, and the requirements of a regional plan in 24 VSA Section 4348, as well as other comments on the Plan and Map. A report on how the draft Regional Plan conforms to the above requirements can be found in the Draft Regional Plan Review Checklist attachment.

Comments may be submitted at the Hearing or sent and received via USPS or email before 5:30 on September 14, 2026, to be considered at the Hearing.
